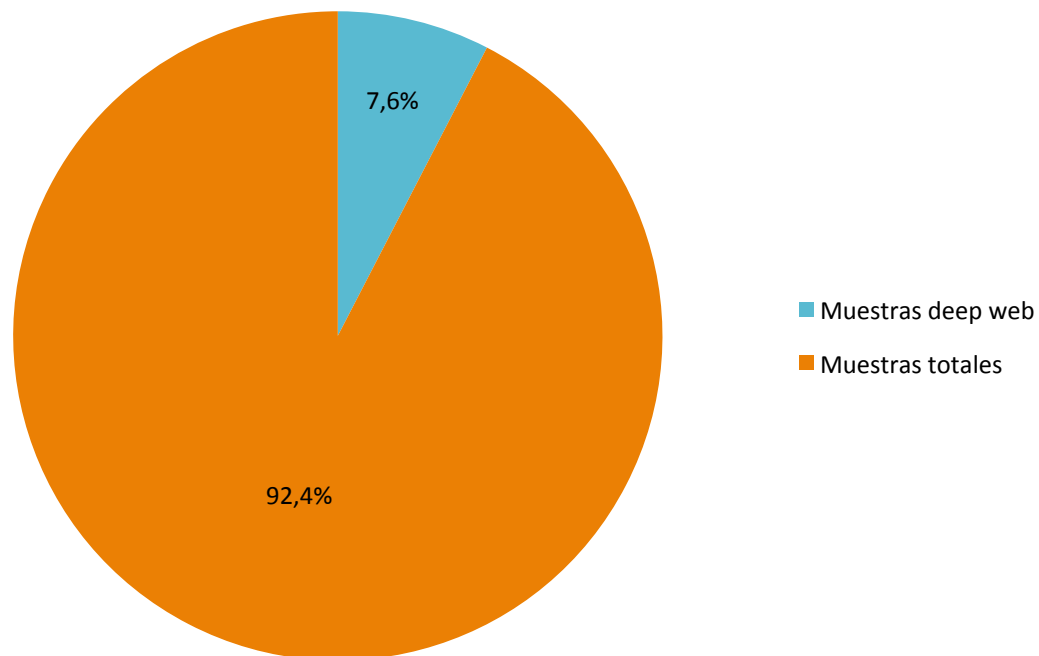

Objetivos

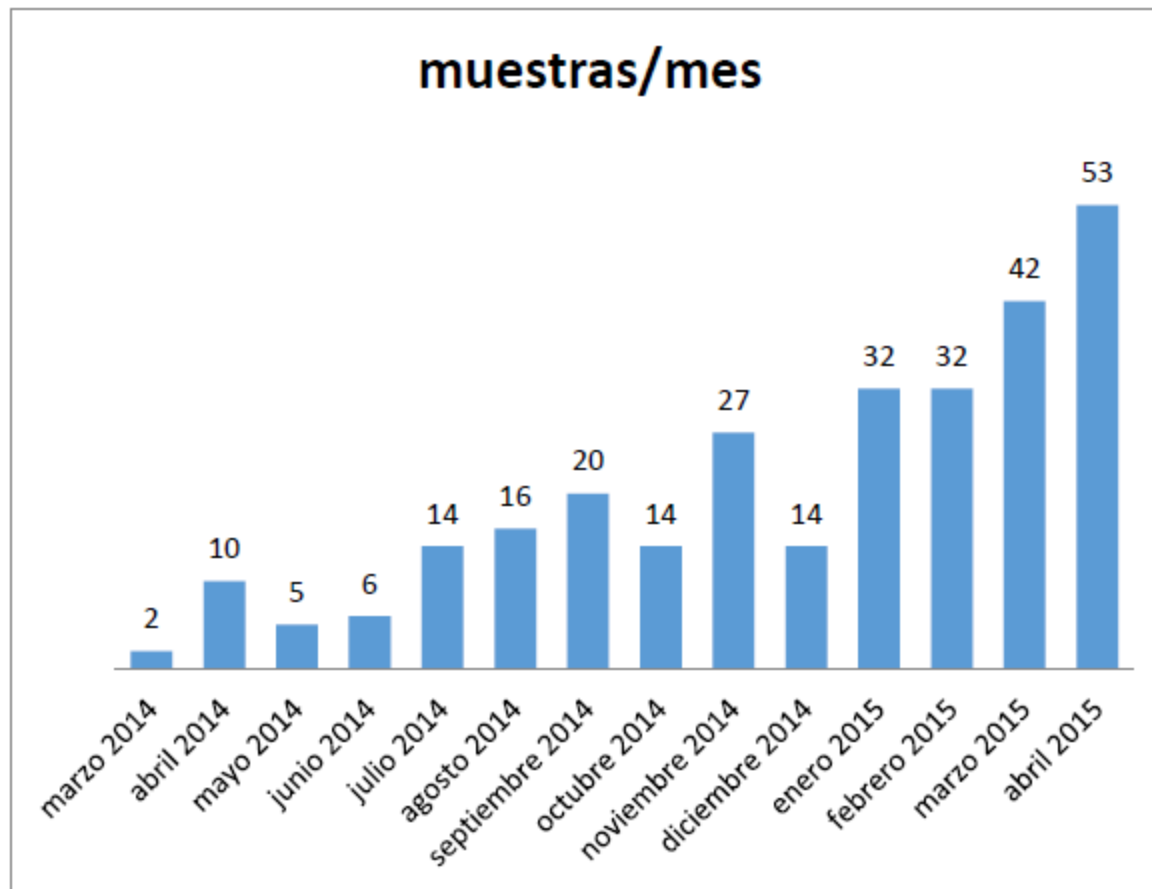

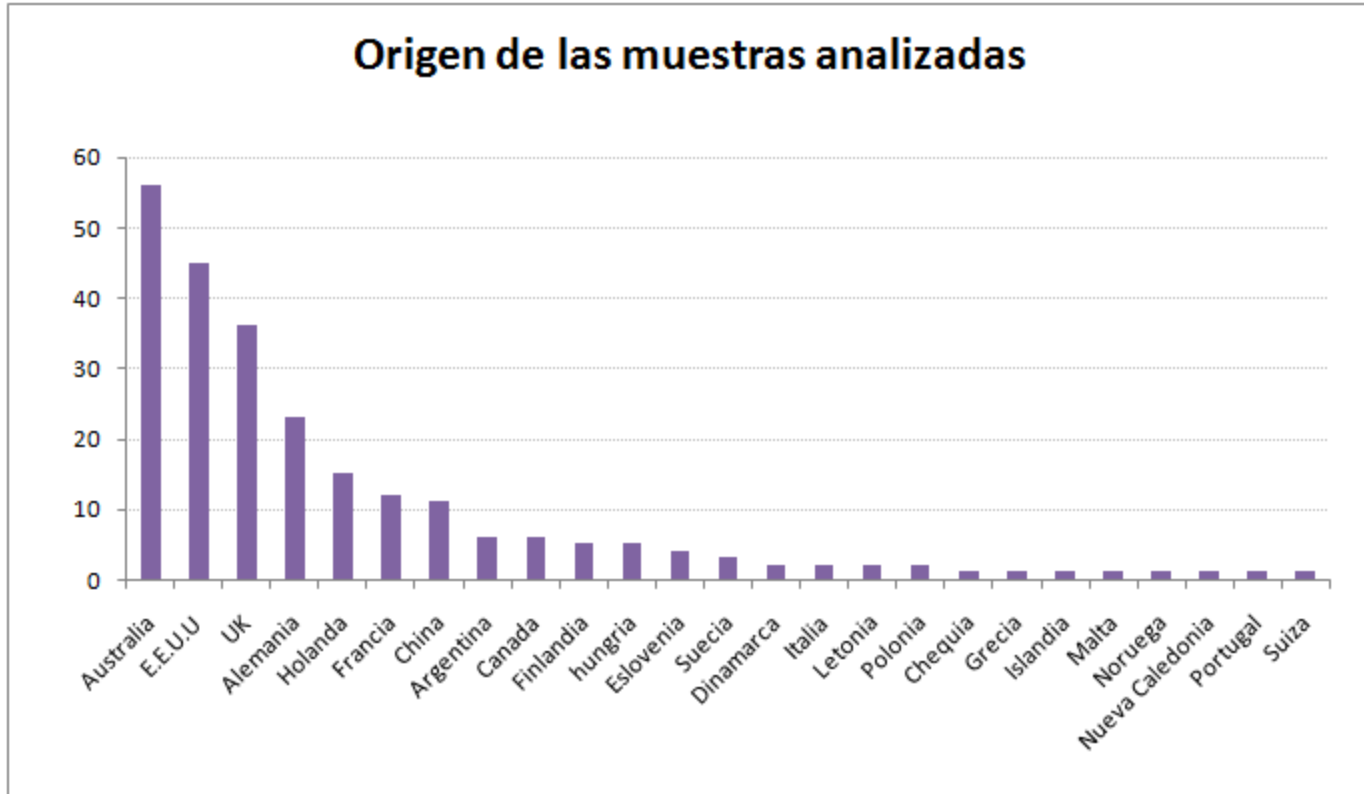

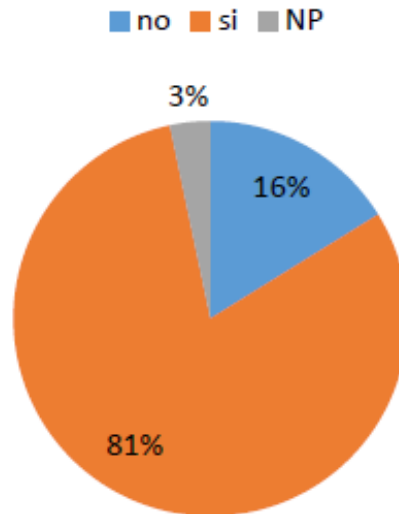

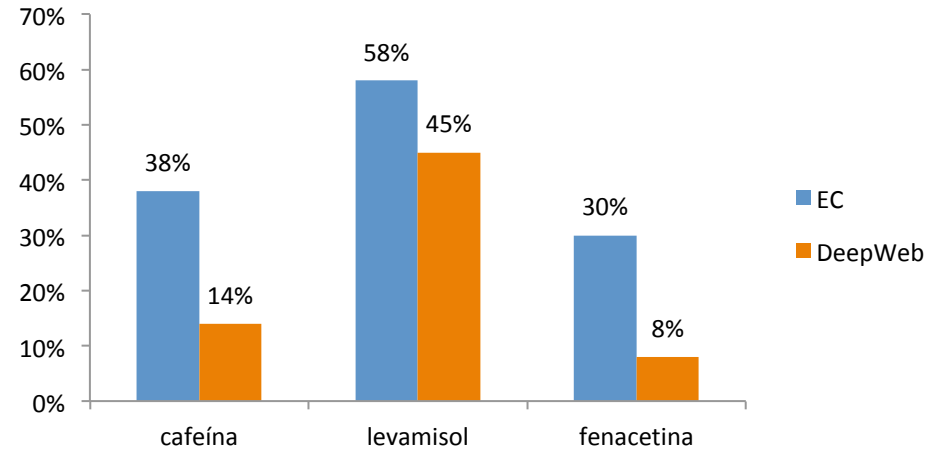

Red sensible a la reducción de riesgos que ofrece grandes oportunidades a los profesionales.

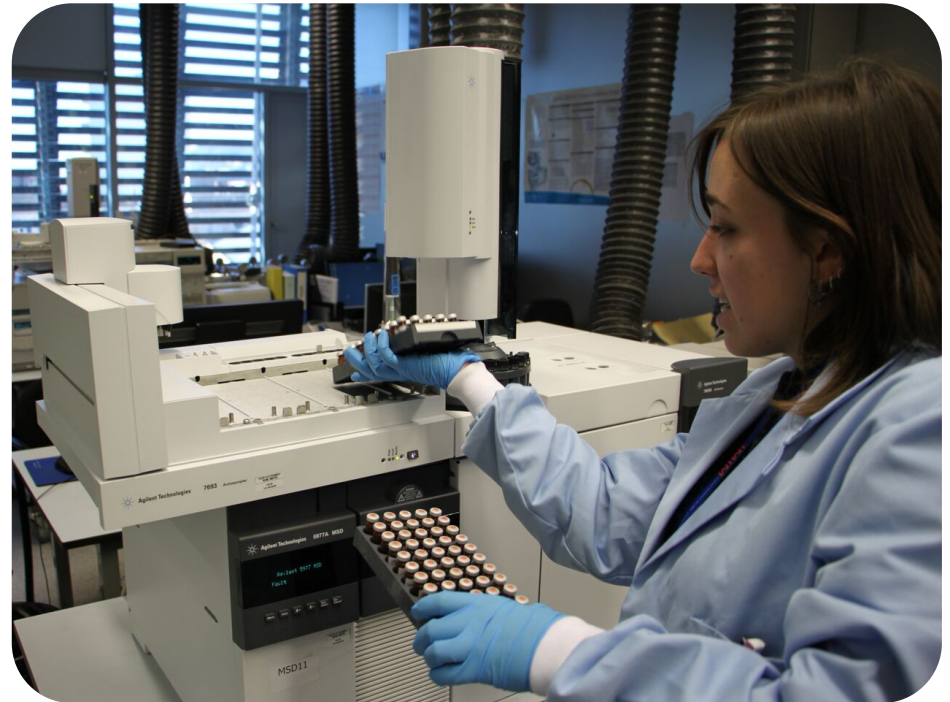
